Certified Capital Market Professional: Dealing in Derivatives for Dealer's Representative (CCMP - Dealing in Derivatives) Frequently Asked Questions

1. What is the Certified Capital Market Professional: Dealing in Derivatives for Dealer's Representative (CCMP - Dealing in Derivatives) programme?

The CCMP - Dealing in Derivatives is a comprehensive training programme for licensed Capital Markets Services Representatives who deal in securities and wish to be additionally licensed for dealing in derivatives. It includes e-learning modules, a trading simulation, and an assessment.

2. Is there any entry requirement for CCMP - Dealing in Derivatives?

Yes. Participants must have a minimum of **two (2) years of experience** as a Capital Markets Services Representative's License (CMSRL) holder for **Dealing in Securities**.

3. How is the programme being delivered?

The programme is conducted virtually and include an E-Learning Programme, Trading Simulation and an Assessment.

4. How do I register for the programme?

- b. Click "REGISTER NOW" button to start with the SIDC online registration system
- c. Key-in your "Email" and "Password", click "Login" to Register
- For new users, you need to create an account before starting with the registration Creating an account is free
- e. Once registered, you will be directed to the payment page where you can make the payment via FPX (online transfer) and Credit Card. Registration is successful once the payment is accepted by SIDC and any request for refunds shall not be entertained under any circumstances.

5. What is the completion requirement for CCMP - Dealing in Derivatives?

To complete the programme, participants must complete the E-learning modules and the trading simulation as well as pass the assessment. A Certificate of Completion will be issued to those who have completed the E-learning modules and the trading simulation. An examination result slip, showing either a PASS or FAIL, will be given to those who have completed the assessment. The passing mark for the assessment is 70%.

6. How do I access the online E-learning and trading simulation?

You will receive an email from SIDC (<u>sidc@sidc.com.my</u>) containing the access link, unique "User ID" and "Password" for you to start all your online E-learning and trading simulation. SIDC will send you the information in a confirmation email upon receipt of full payment.

7. What are the recommended learning hours for the CCMP - Dealing in Derivatives programme? The recommended learning hours are 80 hours.

8. What happens if I fail my assessment?

You can register to re-sit the assessment for a fee of RM550 (the fee is not inclusive of 6% SST). Once registered, you can access your E-Learning modules, trading simulation programme and thereafter attend the assessment.
